

**Reissue of Expression of Interest for four seats on India CCM
Approved at the 86th CCM held on 28th October 2022.**

**Register for Nomination- India CCM- People living HIV/AIDS or living with/previously living
with Malaria, Key Populations with Malaria (2022-2025)**

Date of issue: 21st November 2022

Last date of submission: 15th December 2022

Background: The India Country Coordinating Mechanism (I-CCM) was established by the Ministry of Health and Family Welfare with the goal of strengthening measures to fight HIV/AIDS, TB and malaria in the country under GFATM funding support. It operates on a voluntary basis and is represents a multi-stakeholder partnership of governmental, nongovernmental, CSOs, communities, private sector, academia and development partners. The role of the India CCM is to ensure the proper coordination of the funds within the national response, provide national oversight and ownership of grant implementation. One of the core responsibilities of the India-CCM is to ensure compliance with the Global Fund eligibility requirements and minimum standards. The India CCM initiated the reconstitution of the CCM for 2022 to 2025. An Election Committee (EC) was established to oversee the process of reviewing nominations for the CSO/KP/PLWD constituencies for HIV/TB and Malaria. The India CCM issued an Expression of Interest on July 2022 and circulated it widely for the CSO/KP/PLWD seats for HIV/TB Malaria. Nominations were received by the CCM Secretariat and shared with the EC. The EC reviewed each nomination received based on the criteria established by the CCM and the documentation submitted by the individual and made their recommendations to the CCM.

The 86th CCM meeting held on 28th October 2022 reviewed the recommendations made by the EC after deliberation and concurrence of the CCM members accepted 16 nominations of the 18 submitted by the EC. Two seats for malaria were vacant due to inadequate nominations received and responding to the submission made by the PLHIV community, decided to reissue the EOI for the four seats, 2 for Malaria – (1 for PLWD/1 for KP) and 2 for PLHIV (1 member and 1 alternate).

Objective: The objective of reissuing this Expression of Interest (EOI) is to seek civil society representation from 2 disease categories – Malaria and HIV/AIDS for the following constituencies as listed below to be part of the India CCM, for the term 2022 -2025.

1. Malaria category - 1 seat for PLWD (alternate) 1 seat for KP (alternate)
2. HIV category - 2 seats for the PLHIV category (1 member 1 alternate)

Process:

Please note that the applications received against the slots for the key affected populations (KP) for Malaria and the People Living with the Disease (PLWD) for HIV must be **elected or selected through a process which is well documented**. This means that an organization(s) consisting of members from the respective community must endorse the application. No self-nominations or recommendations of a name by a few individuals will be accepted and will stand to be ineligible. The process needs to be conducted in a transparent manner. The Election Committee will only consider names whose applications have all these documentary evidence attached, besides meeting the eligibility criteria as detailed in the document

Once selected the representative will be required to serve as member of the India CCM for a term of 3 years and participate in at least four meetings in a year.

Each constituency will propose their candidate, and if more than one nomination is received by the India CCM, the recommendation for the final candidates will be made by the Election Committee to the CCM based on the completeness of the application and criteria as shared in the EOI. The final decision rests with the CCM.


Interested candidates may send their application by **15th December 2022** through email indiaccm2021@gmail.com They must indicate in the subject line the position they are applying for.

Eligibility Criteria:

All nominated members/alternates from. KPs, PLWDs should:

1. Not be a Principal or Sub Recipient of Global Fund grants or be working for any PR/SR with active grant in India
2. Have demonstrated experience of working in any one or on all the three areas of /HIV/Malaria in India for at least 5 years.
3. Provide evidence of their capacity to represent the KP/ PLWD constituency in India-CCM not their own organization or network
4. Provide a detailed understanding of how the nominee will establish a communication mechanism from community to CCM and reverse
5. Be willing to sign a Conflict-of-Interest Declaration of India-CCM.
